3. Letter of approval from MOSHE for extension by mentioning the date upto which it is extended.

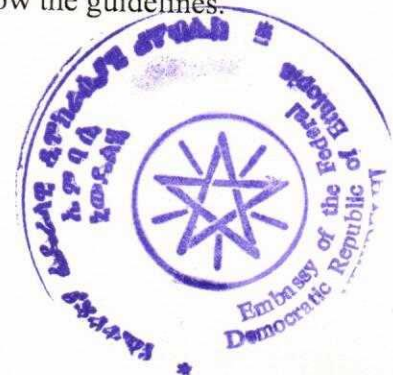
Please communicate with MOSHE, Ethiopia ahead of time for Approval letter.
